GENERAL DESCRIPTION

The frozen endive portions are prepared from fresh, clean, healthy young endive crops of the genus Chicorium Endivia L.

The raw endive is washed, afterwards blanched, cooled, formed and directly frozen.

Cut size: 13 mm

REQUIRES AT THE FROZEN PRODUCT

- colour: uniform light green to greenish brown colour.
- free from foreign material and sand: max. 0.1 % ashes, insoluble in HCL.
- flavour and odour : typical for young, fresh endives. No off-flavour and off- odour allowed.

a) F.M. : not vegetable material such as wood, glass, stones, insects, etc

b) E.V.M. : other vegetable matter as from endive plant.

c) Rest of root piece particles.

d) Damage by insects or disease (rotten).
