GENERAL DESCRIPTION

The mushrooms in this cocktail are chosen from of healty varieties.

The cleaning of the Cep/Penny Bun chunks is done by hand with a brush and knife; no water can be used. The other ingredients are washed and disinfected in 20 ppm chlorine water.

COMPOSITION (IN VARIABLE PROPORTIONS)

Whole Oyster mushrooms 20/45mm: ca 45% Shii-také mushrooms 20/40mm: ca 25% Nameko mushroom 18/20mm: ca 23% Cep/Penny Bun chunks 25/25mm: ca 7%

- Dry matter: equal to fresh product between 8 and 12 %.
