GENERAL DESCRIPTION

Product is prepared from fresh, healthy, very well cleaned curly kale of the genus Brassica Oleracea L.cv. Sabellica Schulz. The curly kale is washed- blanched- cooled off- cut and IQF deepfrozen untill -18°C.

Cut size: 20-40 mm
