GENERAL DESCRIPTION

The red cabbage is proceeded from fresh, healthy, washed, outer leaves free whole cabbage of the genus Brassica Oleracea L. cv. rubra Dc. The cabbage is heartfree made and 1 mm cut.

The cabbage is blanched and IQF deepfrozen lower than - 18°C.

DEFINITION OF DEFECTS

a) F.M. : this includes any non-vegetable material. Examples of foreign matter

include insects, pieces of insects, wood, glass, mineral stones, metal,

slugs, snails, toxic berries etc

b) E.V.M : this includes any vegetable material other than cabbage, which is

derived from the cabbage plant.

c) Clumps : pieces welded together which can not be separated without damage

and > 10 g

d) Hard pieces : (rest of heart) this includes pieces of attached or unattached core

greater than 25 mm in any dimension.

e) Major blemishes : this includes pieces of red cabbage which are blemished to the extent

that the area affected is > 6 mm in diameter

f) Minor blemishes : this includes pieces of red cabbage which are blemished to the extent

that the area affected is between 2 mm and 6 mm in diameter.

g) Total blemishes : major + minor blemishes

h) Oversize :> 3 mm
