GENERAL DESCRIPTION

The product is prepared from sound, clean, ripe fruits of pumpkin (*Cucurbita moschata* 'Butternut').

The product is cleaned, steam peeled, cut into pieces 15x15 mm, blanched and IQF.

DEFINITIONS OF DEFECTS

- a) F.M. : Foreign matter, such as wood, metal, stones, glass, insects, etc.
- b) F.E.V.M. : Foreign extraneous vegetable matter. This includes any vegetable material, excluding the pumpkin fruits, and which is non-toxic.
- c) E.V.M. : Extraneous vegetable matter. This includes any vegetable material of the pumpkin
- d) Clumps : 3 or more clumped together, cannot be separated without damage.
- e) Damaged : pieces damaged by illness or spotted
- f) Badly peeled/skinned pieces
- g) green pieces : pieces with 1/3 of surface with colour green
- h) Pieces with black spots
