#### **GENERAL DESCRIPTION**

The product is prepared from sound, clean, ripe fruits of pumpkin (Cucurbita moschata 'Butternut'.

The product is cleaned, steam peeled, cut into pieces 15x15 mm, blanched and IQF.

#### **DEFINITIONS OF DEFECTS**
