#### **GENERAL DESCRIPTION**

The diced swede are produced from fresh, clean, healthy, whole yellow swede of the genus Brassica napus L. cv. napobrassica Rchb.

Cut size: 10x10x10mm.

#### **DEFINITION OF DEFECTS**

a) F.M. : this includes any non-vegetable material. Examples of foreign matter

include insects, pieces of insects, wood, glass, mineral stones, metal,

slugs, snails, toxic berries etc

b) F.E.V.M : this includes any vegetable material not derived from the swede

plant, and which is non-toxic.

c) Clumps : 3 or more cubes clumbing together which cannot be separated.

d) Gross blemish : dark brown or black area > 25 % of the total area.

e) Major blemish : idem gross blemish but for an area > 6 mm

f) Pieces with greenish discolouration

g) Minor blemish : discolored area between 2-6 mm.

h) Oversize : for dices > 15 mm in any dimension.

i) Undersize : for dices < 8.8 mm in any dimension.
