#### **GENERAL DESCRIPTION**

The diced fennel is prepared from fresh, clean, healthy fennel of the genus Aneth Foeniculum. The fennel is washed, blanched, diced and deep frozen until - 18°C. The temperature should never be higher than - 18°C.

Cut size: 10x10mm.

#### **DEFINITIONS OF DEFECTS**

a) F.M. : Any material such as wood, stones, glass, insects, ...

b) F.E.V.M. : this includes any vegetable matter not derived from the fennel plant,

and which is non-toxic.

c) Clumps : 3 or more fennel dices are welded together and cannot be readily

separated without causing damage.

d) Major Blemishes : pieces with any kind of blemish or colour difference > 6 mm

e) Minor Blemishes : pieces with any kind of blemish or colour difference between 2-6 mm

f) Oxidation : this includes the fennel dice with oxidation. This only includes

the pieces that have a dark brown colour due to the oxidation and

it affects seriously to the aspect of the sample.

g) Badly cut : this includes any dices which have not been cleanly separated or

which are more than twice the nominal size in any dimension.

h) Undersize : < 7 mm in any size.
