GENERAL DESCRIPTION

The sliced carrots are prepared from fresh, clean, healthy roots of the carrot plant
Daucus, Carote L.
Temperature should not be warmer than -18°C.

Size: diameter: 15-35 mm.
Thickness: ca. 5 mm.

DEFINITION OF DEFECTS

- a) F.M. : foreign matter include such as pieces of insect, wood, stones, etc, ...
- b) F.E.V.M. : any vegetable material other than the original plant
- c) Clumps : 3 or more slices clumbed together, cannot separate.
- d) Gross blemishes : black, dark brown or discomposed area > 25 % of the surface.
- e) Major Blemishes : discoloured areas (other than green) greater than 6 mm diameter.
- f) Greenish discolouration: areas more than 6 mm.
- g) Minor blemishes : discoloured areas (other than green) lower than 6 mm diameter.
- h) Total blemishes : small blemishes + major blemishes + greenish discolouration
- i) Broken pieces : when slice is < $\frac{3}{4}$ of the original diameter or when the center is missing.
- j) Irregular Shape : pieces longer than 2x the normal diameter.
- k) Oversize : pieces > 35 mm.
- l) Undersize : pieces < 15 mm.
