PRODUCTION PROCESS

The product is made with ripened HASS avocado which is sorted, washed, peeled, de-stoned and cut. Then the avocado pieces are covered with antioxidant solution and salt. Finally the product is packed under modified atmosphere and frozen.

INGREDIENTS

Avocado: > 99.7% , ascorbic acid (E300), citric acid (E330), salt.
